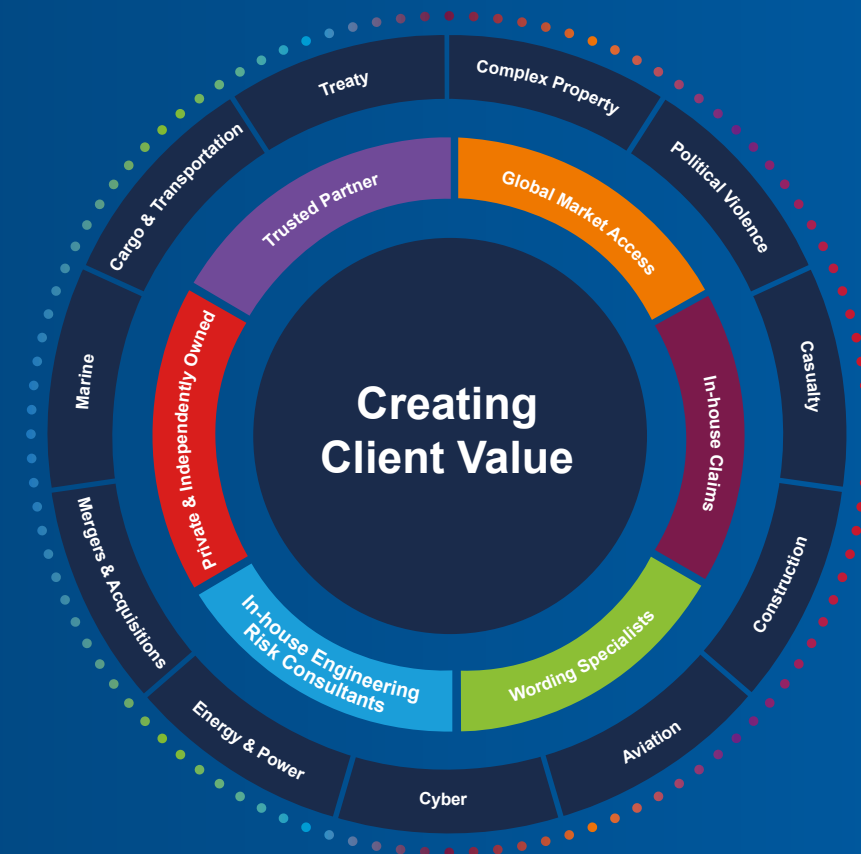
UIB 2023 GEOGRAPHICAL BUSINESS SPREAD
